Facing an increased demand due to the COVID-19 pandemic, the Center is one of the few community-based organizations offering mental health counseling on a sliding scale (as low as \$5 per session) to approximately 1,200 low-income, uninsured Northern VA, DC; and MD residents each year. FY2020, the Center provided 43,600 direct service hours to 4,890 community members. We provided: mental health counseling to 1,672 individuals (62% received reduced fees/free services); crisis intervention, mental health counseling, advocacy, and support to 826 domestic violence victims; financial, career, and mediation services to 2,109 people; referrals to community resources to 7,428 individuals.
