Facing an increase demand due to the mental health crisis, the Center is one of the few community-based organizations offering mental health and domestic violence services, and critical wrap around educational workshops on a sliding scale (as low as \$5 per session) to low-income, uninsured Northern VA, DC, and MD residents each year.

In FY 2022, the Center provided 35,111 hours of direct service to 3,344 individual community members. Specifically, the Center provided mental health counseling to 1,640 community members (56% received reduced fees/free services); group therapy to 61 community members; crisis intervention, mental health counseling, advocacy, and support to 671 domestic violence victims; financial, career, and mediation services to
